Lake Shore Public Schools COVID-19 Preparedness and Response Plan informed by The MI Safe Schools: Michigan's 2020-21 Return to School Roadmap

The health and safety of Macomb County students and staff remains a top priority as we prepare to reopen schools for the 2020-21 school year. Governor Whitmer's Executive Order 2020-142 "provides a structure to support all schools in Michigan as they plan for a return of Pre K-12 education this fall. Under the order, school districts must adopt a COVID-19 Preparedness and Response Plan laying out how they will [respond to the Corona Virus across the various phases of the Michigan Safe Start Plan. In turn, the accompanying Michigan Return to School Roadmap offers a guide to the types of safety protocols appropriate during each phase. There's no one-size-fits-all solution: What works in the Upper Peninsula may not work in Macomb County. Districts will retain the flexibility to tailor their instruction to their particular needs and to the disease conditions present in their regions" (EO-2020-142).

Macomb County Superintendents have been meeting regularly to navigate ongoing challenges in response to the COVID-19 pandemic. They have collaboratively examined best practices in the areas of safety, instruction, and operations, as well as mental and social-emotional health. In partnership with the Macomb Intermediate School District (MISD), District Superintendents have also worked closely with the Macomb County Executive's Office, the Macomb County Health Department, and other community organizations to leverage resources to meet the diverse needs of students, staff and families.

Our ultimate goal is to safely return to face-to-face instruction, as we know this is the optimal learning environment for students. However, during this global pandemic, we recognize the importance of providing a variety of learning options. Districts are working to develop plans for three scenarios to meet the needs of all students: face-to-face, hybrid, and remote learning. In the event that a shift becomes necessary, districts will be able to fluidly transition among instructional options. While this county-wide template was developed collaboratively among all Macomb districts, each district will create its own plan specific to the unique needs of their community. Districts will communicate directly with community members about their specific school district plans.

While no one can predict the future, Macomb County Superintendents have partnered with their local stakeholders to develop customized reopening plans that meet student needs. Each Macomb County district has worked diligently to strengthen remote instruction, improve access to devices, enhance connectivity, and secure personal protective equipment (PPE) so that all students have access to a safe environment and high quality education.

Our mission is to support the academic, social, and emotional needs of Macomb County students. We look forward to the 2020-21 school year and providing our students with equitable, rigorous instruction in a safe environment.

Preparedness Plan Assurances

The District agrees to meet all of the following requirements of Executive Order 2020-142

- ✓ The District assures that when it provides in-person instruction to its students without disabilities, the district must also provide in-person instruction to its students with disabilities, consistent with their individualized education programs (IEPs).
- ✓ The District assures that when schools are closed to in-person instruction, districts must strive in good faith and to the extent practicable, based upon available resources, technology, training, and curriculum, as well as the circumstances presented by COVID-19, to provide equal access to any alternative modes of instruction to students with disabilities from birth through age 26. This assurance includes the provision of auxiliary services under section 1296 of the Revised School Code, MCL 380.1296.
- ✓ The District assures that while any state of emergency or disaster related to the COVID-19 pandemic continues, it shall comply with guidance from the United States Department of Education, including its Office of Civil Rights and Office of Special Education and Rehabilitative Services, and the Michigan Department of Education concerning the delivery of alternative modes of instruction to students with disabilities in light of the impact of COVID-19.
- ✓ The District assures that it shall, to the extent practicable and necessary, make individualized determinations whether and to what extent compensatory services may be needed for students with disabilities in light of the school closures during the 2019–2020 school year.
- ✓ The District assures that during **Phase 1, 2, or 3** of the *Michigan Safe Start Plan* it will close its buildings to anyone except: (a) District employees or contractors necessary to conduct minimum basic school operations consistent with a Preparedness Plan, including those employers or contractors necessary to facilitate alternative modes of instruction, such as distributing materials and equipment or performing other necessary in-person functions. (b) Food-service workers preparing food for distribution to students or their families. (c) Licensed child-care providers and the families that they serve, if providers follow all emergency protocols identified by the state.
- ✓ The District assures that during Phase 1, 2, or 3 of the *Michigan Safe Start Plan* it will suspend athletics, after-school activities, inter-school activities, and busing.
- ✓ The District assures that during **Phase 1, 2, or 3** of the *Michigan Safe Start Plan* it will provide for the continued pay of school employees while redeploying staff to provide meaningful work in the context of the Preparedness Plan, subject to any applicable requirements of a collective bargaining agreement.
- ✓ The District assures that in **Phases 1, 2, or 3** of the *Michigan Safe Start Plan* it will provide for the continuation of food distribution to eligible students.
- ✓ The District assures that during **Phase 4** of the *Michigan Safe Start Plan* it will prohibit indoor assemblies that bring together students from more than one classroom.
- ✓ The District assures cooperation with the local public health department if a confirmed case of COVID-19 is identified, and agrees to collect the contact information for any close contacts of the affected individual from two days before he or she showed symptoms to the time when he or she was last present in school.

GENERAL INFORMATION

VIRUS STATUS

PHASES 1 - 3

- Community spread of the virus is increasing and substantial.
- There is concern about healthy system capacity.
- Testing and tracing efforts may not be sufficient to control the spread of the pandemic.

PHASE 4

- The number of new cases and deaths has fallen for a period of time, but overall case levels are still high.
- Most new outbreaks are quickly identified, traced, and contained due to robust testing infrastructure and rapid contact tracing.
- Health system capacity can typically handle these new outbreaks, and therefore case fatality rate does not rise above typical levels.
- The overall number of infected individuals still indicate the need for distancing to stop transmission and move to the next phase.

PHASE 5

- New cases and deaths continue to decrease for an additional period of time.
- At this point, the number of active cases has reached a point where infection from other members of the community is less common.
- With widespread testing, positivity rates often fall much lower than earlier phases.
- Rapid case investigation, contact tracing, and containment strategies cause new cases to continue to fall.

PHASE 6

Post-Pandemic.

- Few, if any, active COVID-19 cases locally.
- Community spread not expected to return.
- Sufficient community immunity and availability of treatment.

SAFETY PROTOCOLS: Personal Protective Equipment LOCAL IMPLEMENTATION STRATEGIES

- Facial coverings are required for all preK-12 students on busses, classrooms, common areas, and hallways. As defined in the Governor's Executive Order 2020-142: "A facial covering is cloth material that covers the nose and mouth. Facial coverings may be secured to the head or simply wrapped around the lower face. They can be made of a variety of
 - materials, such as cotton or linen, and may be factory-made or made by hand."
- Facial coverings, gloves, and other required PPE will be provided for all staff, and will be made available via each building or department through the district's/county's PPE Committee for Safe Back-to-School planning. A note from a physician will be required for facial covering exemption.
- Accommodations within the classroom must be considered for students that are not able to tolerate wearing a facial covering (developmental, disability, medical issues, etc).
- Face shields will be encouraged for those staff and students who are not medically able to tolerate a mask type facial covering.
- Signage regarding acceptable and required PPE and hygiene practices will be posted throughout the buildings and at each entry point.

- Hand washing/sanitizing will be available for all students upon moving throughout the building, before and after eating and activities, etc. Staff members will distribute and monitor the use of hand sanitizer, especially for young children.
- Classroom activities where supplies would normally be shared will be limited and arranged by cohorts as feasible. An example would be the use of science materials, where students would stay with the same group daily and wear gloves.
- Students will be advised to use hand sanitizer as they enter a new space in the building, with staff supervision. Staff will follow the same procedures.
- Teach proper hand washing techniques
- Build time into the daily class schedule to support hand washing every 2-3 hours
- Offer rewards to acknowledge student efforts and active participation in good hygiene for clean hands, personal belongings and mask use
- Use videos to teach students the importance of hand washing and mask hygiene
- Engage the parent social media teams and PTO to help spread the word about building hygiene habits 2-4 weeks before classes begin
- As part of the registration process or other measurable means for documentation educate parents on how COVID is transmitted, proper handwashing, hygiene for masks, and how to properly put on and remove a mask to avoid contact transfer
- Address personal belongings with the goal that students do not share their school supplies
- Restrict or eliminate use of lockers
- Provide PPE for stakeholders as needed

SAFETY PROTOCOLS: Spacing, Movement and Access LOCAL IMPLEMENTATION STRATEGIES

- Student desks will be spaced as feasible.
- Training in individual school buildings will address remaining six feet (or more) apart in hallways and staggered movements, and will be monitored by staff. This will include walking on one side of hallways (staying to the right), one way stairwells, etc.
- Staff members will work to maintain a six feet distance from others while at work in school buildings.
- Family members or other guests are not allowed in the school building except under extenuating circumstances determined by district and school officials.

Schedule

- To adhere to social distancing guidelines the district will work toward phasing in a blended 50% in person model of instruction while in Phases 4 and 5
 - Priority will be given to preK-5 students, special needs students, and transitional grades (6 and 9) to return to in person instruction, at the maximum time and days that
 distance safety protocols will allow. Courses that are particularly suited for in person learning (band, choir, CTE, etc.) will also be given priority for return to in person
 instruction.

Arrival & Dismissal

- Support staff/hall monitors/available staff assigned to grade levels and hallways (cohorts)
- At arrival students line up outside of cohort doors, with a staff member monitoring social distancing and taking temperatures as needed until it is time to enter the building
- Assign cohort entrances as close to grade level hall as possible
- Doors open at assigned times by support staff/hall monitor
- Every student sanitizes before entry into building
- Teacher at classroom door ensuring students do not congregate in halls
- Assigned support staff/hall monitor to disinfect assigned entrance after tardy bell
- Assigned support staff/hall monitor to get escort their cohort of tardy and breakfast students to their classroom
- Staggered dismissal times where necessary to support social distancing (consider siblings and building specific traffic)
- Assigned support staff/hall monitors at cohort doors assisting teachers in student dismissal
- Identified rooms for late pick up after dismissal to minimize office traffic
- No re-entry from cohort doors after leaving the building

Lockers

Restrict or eliminate use of lockers

Breakfast & Lunch

- Scheduled breakfast time in cafeteria or students eat in classrooms following CDC guidelines
- Hall monitor/support staff person assigned to breakfast entrance doors to take escort students to the cafeteria or have breakfast delivered to classrooms
- Students/parents select breakfast and lunch choices online and can preorder in advance
- Avoid cash transactions. Implement paying online. If not possible to pay online, place funds in a sealed envelope and placed in a drop box

Office

- Separate, assigned room for students to wait at dismissal who are picked up late
- Parents dropping off forgotten items may not enter the building. Provide a drop box outside of the office for them to leave the item. Assign a staff member to periodically check the bin and deliver items to classrooms
- Plexiglass barriers for school secretary spaces

Any positives should prompt parents or guardians to keep the student home from school. 	

SAFETY PROTOCOLS: Screening Students, Staff, and Guests LOCAL IMPLEMENTATION STRATEGIES

- HIPAA and FERPA laws will be taken into consideration for all who may fall ill and/or contract COVID-19, and additional training and guidelines will be provided for all staff.
- N95/KN95 masks will be provided wherever necessary through our partnership with the Macomb County Health Department.
- Entrances and exits have been determined according to on-site safety protocols. Points of entry have been minimized, and these protocols will continue to be followed and monitored.
- Communication to all families regarding following the return to school protocols will be presented in multiple forms.
- An online review of the Lake Shore Preparedness and Response plan will be completed by parents prior to a return to in person instruction.
- Family members or other guests are not allowed in the school building except under extenuating circumstances determined by district and school officials.
- All guests through employment that must enter a building during school hours, must fill out a screener and have a temperature check. (CPS, Vision/Hearing).
- Conferences and IEP/504 meetings are held virtually whenever possible.
- Staff members will not be allowed family members into a building during in person instruction until phase 6 (this excludes SACC services).

A designated quarantine area at all buildings for students or staff members who become ill during the school day.

- Quarantine area will be staffed by a Medical Assistant-Certified (MA-C) to care for the students and staff who become ill during the school day.
- Entry doors to quarantine spaces must be locked. Entry will be granted by the MA-C or by a keyed staff member wearing proper PPE.
- Quarantine areas should be set-up to establish 6 feet of social distancing of the occupants when space is available.
- Building administrators will establish procedures for parent pick-up from quarantine areas.

Students who become ill with symptoms of COVID-19 will be placed in an identified quarantine area with a surgical mask in place until they can be picked up. Identified school staff caring for these children should wear a surgical mask, with the exception of students with special needs requiring aerosolized procedures in which an N95mask is required.

When a student notifies a staff member they are ill during the school day the following will occur: Classroom to Quarantine:

- If the student is in distress, follow proper emergency guidelines and call for emergency assistance.
- Classroom teacher will contact the designated building escort to walk the ill child to the quarantine area.
- Building escort will arrive wearing a surgical mask and provide a surgical mask to the student. The student will replace their current mask with the provided surgical mask.
- Building escort will direct (and if necessary, provide assistance to) the student to gather their belongings and place them in a bag, provided by the building escort.
- Building escort will walk the student to the quarantine area.
- Building escort will make a direct introduction of the student to the MA-C, ensuring the MA-C has taken over responsibility of care for the student. If the MA-C is engaged in active care of another student, the building escort will wait until acknowledgment and introduction can be made.
- The student will then be directed to sit in one of the marked chairs with their belonging bag.
- The building escort will leave the quarantine area and proceed directly to the nearest handwashing station (wash hands, as per the CDC guidelines) to wash hands and change their mask.
- The remaining students and the staff member in the room affected by the ill student should be relocated for the remainder of the day or until cleaning/disinfecting can take place in the classroom or area.

• The remaining students and staff member(s) should be directed to wash their hands and continue with their day.

Symptomatic students sent home from school may return in accordance with requirements established by the Macomb County Health Department.

Staff will conduct daily self-examinations, including a temperature check, prior to coming to work. If they exhibit COVID-19 related symptoms, they should stay home.

Families will check their child's temperature at home every morning using oral, tympanic, or temporal scanners; students with a temperature of 100.4 or greater must stay home and consider coronavirus testing if symptoms of COVID-19 are present.

Families will monitor their children for symptoms of COVID-19. The presence of any symptoms, including cough or shortness of breath, should prompt the family to keep the student home from school and to follow up with a primary care provider.

An electronic screening tool for employees and students will be utilized.

Staff members will monitor students upon arrival and throughout the day and temperature checks will be performed as warranted.

Staff will be trained on the use of no-touch thermometers.

- Provide all staff with timely, responsive, and ongoing training/professional development as well as needed tools, resources, and implementation support, focused on a variety of topics, including: social-emotional learning, trauma-informed best practices, identification of students at risk, proper local referral protocols, and self-care to promote holistic wellness and resilience and to prevent burnout and vicarious trauma.
- Establish a comprehensive crisis management plan that leverages available internal and external/ community-based resources, which can be activated efficiently as needed (e.g., loss of student, loss of a school staff member).
- Compile and regularly update comprehensive lists of wellness resources available to both staff and students that can be provided in conjunction with screening activities, and that reference school and community wellness resources.

- Encourage schools to implement a mental health screening for all students by a trained professional, if possible. Any screening should be compliant with HIPAA and FERPA policies. Screening instructions (offered verbally to younger students) should provide age-appropriate and transparent disclosure of protocols in place to protect confidentiality while adhering to mandated reporting guidelines.
- Establish and communicate to all staff guidelines for identification and rapid referral of at-risk students to appropriate building-level support teams.
- Provide all staff with timely, responsive, and ongoing training/professional development as well as needed tools, resources, and implementation support, focused on a variety of topics, including: social-emotional learning, trauma-informed best practices, identification of students at risk and proper local referral protocols, and self-care to promote holistic wellness and resilience and to prevent burnout and vicarious trauma.
- Encourage the identification of a point person or establish an access navigator to centralize mental health referrals, communications to families/ students, and public-facing wellness materials.
- Establish a comprehensive crisis management plan that leverages available internal and external/ community-based resources, which can be activated efficiently as needed (e.g., loss of student, loss of a school staff member).
- Compile and regularly update comprehensive lists of wellness resources available to both staff and students that can be provided in conjunction with screening activities, and that references school and community wellness resources.
- Establish ongoing reporting protocols for school staff to evaluate physical and mental health status.
- Provide resources for staff self-care, including resiliency strategies.
- Designate a mental health liaison (school-based) who will work across the school, local public health agencies, and community partners.
- Leverage MDE resources for student and staff mental health and wellness support.
- Activate communication channels for school stakeholders to address mental health concerns resulting from COVID-19 (for example, a telephone hotline or a designated email).
- Communicate with parents and guardians, via a variety of channels, return to school transition information including:
- o Destigmatization of COVID-19;
- o Understanding normal behavioral response to crises;
- o General best practices of talking through trauma with children; and
- Positive self-care strategies that promote health and wellness.

All staff will work together to provide this support, including teachers, principals, counselors, social workers, etc.

To maintain connection to existing supports that were in place prior to the closure of school buildings, the district will share resources so families can connect with professional, certified staff who provide support services to families at the school level. The district will also provide access to the information related to COVID-19 provided by the county, state, and federal resources, including the Center for Disease Control (CDC), the Michigan Department of Health and Human Services (MDHS), and the Macomb County Health Department (MCHD).

- Take time to build partnerships, deepen understanding, and plan for SEL.
- Design opportunities for adults to connect, heal, and cultivate their own SEL competencies and capacities.

The district and school leaders will promote and support opportunities for positive feedback/connection between students and teachers, and acknowledge individual students' current situation and context. All students will have access to appropriate supports to process events, schools and teachers utilize trauma-informed practices, when possible. School staff will utilize school and community resources to provide mental health supports and leverage the use of Guidance Counselors/Social Workers for ongoing support and check-ins.

Phase 1-3

Macomb County districts recognize that a variety of alternative modes of instruction need to be provided to meet students' diverse needs. These learning options include hard copy media (paper), mixed media (hybrid), or digital media, depending on the tools and resources accessible to each student. We will continue to gather feedback from all stakeholders about their experiences with remote learning through a variety of methods (e.g., surveys, virtual focus groups). Information provided by stakeholders will be used to help districts make decisions and improve the remote instruction provided to students.

Modes of instruction will be clearly communicated by districts and available to students and parents so they can select which option(s) best meets students' needs and their individual situations at home.

Phases 4-5

County-level leadership teams have met regularly since the closure of brick and mortar schools and will continue to meet regularly. Additional return-to-work groups include leaders from Macomb County school districts, the Macomb Intermediate School District, Macomb County's Executive's Office, Macomb Community College, other post-secondary institutions, and community partners. These groups meet consistently to gather and analyze feedback, adjust learning plans based on stakeholder input, and share the revised instructional options. In addition, Macomb County local districts have established return-to-work teams focused on creating a safe and productive environment for all stakeholders.

Modes of instruction will be clearly communicated by districts and made available to students and parents so they can select which option(s) best meets students' needs and individual home situations.

Lake Shore Public Schools MISafeStart planning committee includes focused work around Instruction facilitated by the Assistant Superintendent of Academic Services. Subcommittees were formed for *in person instruction, virtual/remote learning, professional development, communications and athletics.* Subgroups were led by building administrators and staff, and included parents and community members.

- A Schoology Group was created for curation, resource sharing and feedback opportunities. **ALL** staff had the opportunity to join the group, even if not officially participating with committee work.
- Committee and subcommittee virtual meetings were recorded. Meetings, agendas and working notes were all posted in the Schoology group, for access by teaching staff and other committees to stay apprised of the work.
- The process, and the work, was communicated using standard district communication tools, including School Messenger, Social Media and email.
- Parent, student and staff surveys, taking during and after school building closure, contributed to the recommendations of the committee.
- In-person, blended and 100% virtual options will be made available to families, with focus on keeping students connected to their school communities regardless of their learning choice. These are not separate academies or schools, but methods of delivery to personalize instruction for students. A Shorian is a Shorian regardless of where instruction and learning occur.

Protocols, and learning opportunities, will remain the same under Phases 4 and 5. Sustained time at Phase 5 will trigger a re-evaluation.

Where feasible and resources permit:

The district will communicate learning plans to all stakeholders in various home languages. District may also use its English language support system, including the MISD bilingual services, to communicate with non- and limited-English speaking families. Although the district is equipped to support students and parents by communicating frequently via multiple modes, there is still a need to revisit communication in multiple home languages.

Macomb County districts are prepared to deliver remote instruction. The district will strive to provide access and tangible resources in lieu of technology as needed. The district will continue to gather input from families about their remote learning experiences and utilize this information to revise and strengthen learning opportunities provided to students. This data will also be used to deepen relationships to meet the needs of students, families, and staff.

Macomb County districts have drawn on several remote instructional frameworks in order to meet the instructional and social emotional needs of Macomb County students. These models include: <u>Universal Design for Learning (UDL)</u>, <u>Learning Forward</u>, <u>MCREL's Kickup</u>, and Collaborative for Academic Social Emotional Learning (<u>CASEL</u>).

The district has created structures to implement high quality instructional learning for remote contexts in synchronous and asynchronous environments. Macomb County continues to provide professional learning for staff regarding setting up and leading online learning experiences. Teachers may utilize county developed templates for consistent instructional delivery through various platforms including BlackBoard, Google Classroom, and Schoology. Teacher collaboration and ongoing professional development will be offered to strengthen teachers' ability to customize remote instruction according to students' needs. Teachers will highlight routines and structures to engage students in new learning based on essential standards, and provide students with opportunities to submit evidence of their learning. They will measure student progress and provide students and parents with ongoing, timely feedback about their learning. In addition, teachers will intentionally create emotionally and physically safe and supportive learning environments for students to develop deep relationships with teachers and peers.

Viable and reliable remote assessment is a concern for many districts in the county. Although there are assessment programs in place to meet this need, nothing can replace the connection of a teacher and student physically in a classroom setting engaging formative observations of learning and the application of knowledge. The district will administer screening and diagnostic assessments as appropriate, to better understand each student's current academic level and inform instructional starting points. The district will continue to utilize benchmark and formative assessments to measure student progress and inform instructional next steps.

The Macomb Intermediate School District, in partnership with its local school districts, will continue to collaborate with the Detroit Regional Foundation and the Ballmer Foundation to provide counseling services to students and parents throughout the summer months to help solidify post-secondary plans.

The district and school leaders will engage in data analysis around curriculum and instruction to monitor student progress and make instructional adjustments. Staff members will use a Multi-Tiered System of Support to identify student needs, provide tiered interventions and monitor student progress. All staff will work together to provide this support, including teachers, principals, counselors, social workers, etc. by regularly communicating with students and families.

The district and school leaders will engage in data analysis around curriculum and instruction to monitor student progress and make instructional adjustments. Lake Shore Public Schools will design learning and communication protocols to allow a more seamless transition between remote, in-person and (choice) 100% virtual instruction.

- Remote and 100% Virtual Instruction will be taught by Lake Shore Public Schools certified staff, using district curriculum and resources, to the extent possible.
- Use of Schoology as the Learning Management system K-12.
- Integration of SeeSaw at K-2 for appropriate digital learning opportunities.
- Streamline communications using School Messenger and Schoology for district, building and classroom communications.
- Creation of non-digital learning kits, by grade level and content as appropriate, to ensure developmentally appropriate access to learning that is supported through our digital platforms.
- Scheduled synchronous and asynchronous learning.
- Multi-tiered systems of support remain in place for both academic and social-emotional well-being.
- Consistency in course format aligned to developmentally appropriate organization, including weekly agendas, daily focus and parent communication.
- Feedback on learning, including due dates and deadlines, will inform assessment and grading. At the elementary, standards-aligned reporting will continue. At secondary schools, students will earn quarterly informed, semester grades for credit.
- Assessments for progress monitoring will continue virtually with District MTSS systems already in place, and will require the assistance of an adult in the home for K-5.
- Models for establishing home learning, including schedules and spaces, will be communicated.
- Families needing assistance with independent work will be supported virtually through district support staff.
- A return to in person instruction from remote learning, whether due to moving from Phase 3 or to establish a safe return during Phases 4 and 5, will consider beginning with a staged return that limits students and staff in a building. The goal will be a return of students at all levels, Pre-K 12, to a minimum of a 50% in person instruction.
 - K-5, students with special needs, transition years and/or courses that are not well suited to remote learning may be phased in at a level greater than 50% in person as spacing and safety measures allow.

Protocols, and learning opportunities, will remain the same under Phases 4 and 5. Sustained time at Phase 5 will trigger a re-evaluation.

County and district professional learning has been ongoing regarding best practices for remote instruction using technological and non-technological delivery methods.

Providing access in all subject areas will prove challenging and is a concern when districts are unable to hold in-person classes. While we understand best practice is face-to-face instruction, staff members are working to design quality learning options for all students. The district will continue to be flexible in addressing all student needs and make adjustments as needed. Lake Shore has created teams to ensure this is implemented and that follow through is organic, supported by our Professional Learning Communities.

Phase 4

The district will communicate expectations for teaching in face-to-face, hybrid, or remote contexts. The district will activate best practice learning at scale, with standards-aligned curricula and high quality instructional materials. The district, schools, and teachers will continue to strengthen synchronous and asynchronous opportunities using best practice instructional strategies for both remote and face-to-face contexts. The district will promote interaction with content in a variety of formats, which foster student engagement, consistency, and differentiation.

District will encourage grade level/content area teams to collaboratively identify essential standards (concepts) and grade level proficiencies. Teacher teams will also create learning progressions, learning targets, and pacing guides reflective of essential standards (concepts). Lesson plans will include formative checks and scaffolding to meet the needs of all students. District and schools will utilize specific instructional platforms and delivery methods while clarifying expectations for students and parents.

District will create systems of equity and access for all students. District will identify staff responsible to determine levels of interventions for students not participating or responding to instruction. Special and general education teachers will continue to work collaboratively to meet IEP goals and provide accessibility to any assistive technologies as needed. Specific skilled personnel participating in this system may include teachers, administrators, counselors, social workers, etc.

District may draw from frameworks such as CASEL or STARR Commonwealth, and use the actionable recommendations to ensure the social and emotional needs of all students and adults are addressed.

The Macomb ISD will work with districts to continue providing professional learning support directly related to stakeholder needs. These job-embedded supports will be differentiated according to content and instructional delivery modes. The Macomb ISD will utilize feedback to bring professional learning and services to scale.

Lake Shore Public Schools will continue to evaluate and prioritize standards aligned learning experiences that prepares students for the skills necessary beyond their K-12 experience.

- The district special education team held scheduled IEP and 504 meetings prior to the end of the school, and evaluated those students that may need EYS during Summer 2020.
- LSPS partnered with MISD summer learning programs to reach K-8 At Risk students in literacy and math. Kennedy middle school conducted transition camps for incoming 6th graders and out-going 8th graders. Credit recovery for high school, as well as instructional support for students behind academically in middle school were made available through summer programming that transitioned to virtual offerings.
- Progress monitoring will be done at the beginning of the school year, most likely in the first 30 days, to assess students holistically as well as to inform IRIPS and tiered systems of support academically, and for social and emotional wellness.
- The district has a long history of instructional decision making through Professional Learning Committees, which is a continuous process of identifying prioritized standards, assessment and creating plans for students who need acceleration and support.
- Lake Shore has had 1:1 ChromeBook devices for three years in secondary buildings and two years in elementary buildings. Infrastructure and support of Internet access at home, was confirmed during the building closures. Systems of remote support of devices, including help desk, email and scheduled availability to return devices for repair, are in place.
- Software and digital systems were evaluating, and will be on an ongoing basis. Licenses for screencasting, digital literacy and books, elibrary cards to the public library system, as well as content specific digital licenses have been procured or renewed.
- District Social Workers attended summer training with Starr Commonwealth on Trauma and Understanding to support Social/Emotional Wellness as a priority for return to school.
- MiSafeStart Return to Learning Committee developed guidelines for learning expectations whether remote, 100% virtual (choice) or in person instruction.
- The district plan for students and families who choose to be 100% virtual, regardless of the phase, will be instructed using the district remote learning plan for phases 1-3. One difference is the availability of some non-core academic courses, which don't lend themselves well to remote instruction or have limited interest, making it infeasible to run a virtual course.
- Psychological assessments that were postponed during building closure will be prior to the start of the school year to the extent possible with social distancing and safety guidelines, as well as the comfort level of families.

Protocols, and learning opportunities, will remain the same under Phases 4 and 5. Sustained time at Phase 5 will trigger a re-evaluation.

During these unprecedented times, the connectedness and care for our students and one another is our first priority, as we strengthen our remote teaching and learning. the district is well-equipped to support students and parents and to communicate plans frequently via multiple modes.

Where feasible and resources permit:

The district may revisit communication and parent training options in multiple languages. The district will continue to provide parent training via appropriate, physically-distanced modes to support remote learning. Reaching students and families will continue to be a strong focus for the district. Channels of communication with students, staff and families include phone, email, district websites, learning platforms (BlackBoard, Google Classroom, Schoology, etc.) and social media.

Communication will address district protocols, grade level expectations for teaching and learning, teacher accessibility for check-in with students and families, processes for feedback and monitoring of student learning, and prioritizing social-emotional wellbeing. The district will communicate with students and families who do not have internet access via phone, mail, or home visits.

In partnership with the MISD, the district provided instructional support over the summer months (EL Camp, First Grade Fundamentals, Kinder Connect, Math Camp, recommended reading lists by grade level, SAT preparation, and STEM support) to meet students where they are and prepare them for the upcoming school year. The data from these programs will be utilized to inform 2020-21 instruction and MISD professional learning services. Additional resources include:

Educators will have opportunities for virtual professional learning and to further develop their Professional Learning Communities in a remote learning environment. This will include but not be limited to curriculum review, lesson planning, data collection and analysis, and climate/culture work.

Phase 1-3

Macomb ISD, together with district leaders, will continue the practice of analyzing survey data and working to provide additional professional learning to meet the instructional needs of staff members county-wide. Professional learning and support will continue to be provided to strengthen staff capability to meet the remote learning goals in the district. The district has a variety of ways to support staff and will focus on the essential skills needed for daily success. The MISD website is updated frequently to reflect online professional learning opportunities as district needs are identified. Professional learning topics include but are not limited to:

- Getting Started with Online Learning; Getting Started with Schoology; Special Education Design; Accessibility;
- Other Considerations when Providing Enrichment; Meeting Your Classroom Online: Options for Virtual Connections; Discovery Education Experience; Coaching and Intervention Collaborative Meetings;
- Trauma Informed and Resilience Professional Learning; social and emotional framework and tools.

Mechanisms to support collaboration among staff members will be enhanced to promote continued learning and connectedness around instructional best practices, equity and implicit bias, social-emotional learning, and culturally responsive education. Teams will have opportunities to exchange information about student assessment results, progress, and assignment completion. Teacher teams will work collaboratively to define age appropriate workloads, timeframes, consistent instructional methodology, monitoring, and feedback. This collaboration among staff will increase equity for students, enhance staff's capability to provide high quality remote teaching, and increase collective efficacy among teachers.

Phase 4

The district will build upon the professional learning plans of Phases 1-3.

Whenever feasible and as resources permit, the district will continue to conduct intentional curriculum planning and documentation through the course of the school year to ensure stability of instruction.

The district will strengthen their systems of equity and access for all students. Staff responsible for determining levels of interventions for students not participating or responding to instruction will be identified by districts. Specific skilled personnel participating in this system may include teachers, administrators, counselors, social workers, etc.

Lake Shore Public Schools, in alignment with the MICIP, district vision and mission, will continue to provide professional development for instructional transformation, while supporting the added needs of remote and virtual learning.

- District calendar includes six days of DPPD for instructional minutes that will be utilized in addition to two days prior to the start of the school year.
- Emphasis prior to school start date will be safety procedures and protocols (PPE, movement protocols, etc), social and emotional wellness, and standardization of learning platforms.
- Beginning September 14th, all instructional staff will engage in a Remote Learning Essentials, facilitated with our learning partners Communications by Design (CBD).
- The district will employ two part-time in-district learning coaches and contract CBD to provide virtual coaching Mon-Fri 8a.m. 4 p.m.)
- Additional webinars, coaching and learning opportunities through coaches and CBD partnership will be identified through the PLC process and in consultation with District Improvement teams and the District Curriculum Committee.

Additional support agencies may be sought to make these connections.

Teachers will measure student progress and provide students and parents with ongoing, timely feedback about their learning. Teachers will also provide students with opportunities to self-assess the quality of their work, reflect on teacher feedback, and learning progress.

Lake Shore Public Schools evaluated the success of Remote Emergency Learning and used the feedback to establish remote MTSS systems.

- Clear expectations of assignment due dates, deadlines, feedback expectations (minimum once weekly) are established and will be communicated to students and families by the teacher.
- Attendance at required synchronous activities, as well as participation in asynchronous learning, including submission, feedback and two-way communication, will be used to identify students in need of follow up. A tiered system of intervention regarding participation is developed at each building.
- Schoology will be the communication and entry point for all remote and virtual learning. Learning experiences will include synchronous lessons and support, asynchronous instruction, digital activities and assignments, as well as curriculum program workbooks, textbooks, manipulatives, learning games, STEAM and creativity assignments to engage offline.

The district will communicate expectations for teaching in face-to face, hybrid, or remote contexts. The district will strive to activate best practice learning at scale with standards-aligned curricula and high quality instructional materials. The district, schools, and teachers will continue to strengthen synchronous and asynchronous opportunities using best practice instructional strategies for both remote and face-to-face contexts. The district will promote interaction with content in a variety of formats, which foster student engagement, consistency, and differentiation.

The district will encourage grade level/content area teams to collaboratively identify essential standards (concepts) and grade level proficiencies. Teacher teams will build upon existing learning progressions, learning targets, and pacing guides reflective of essential standards (concepts). Lesson plans may include formative checks and scaffolding to meet the needs of all students. In addition districts and schools will determine work products, submission guidelines, and mastery of content/success indicators.

The district and schools will use specific instructional platforms and delivery methods while clarifying expectations for students and parents. The district will conduct intentional curriculum planning and documentation through the course of the school year to facilitate the stability of instruction appropriately. The district and schools will engage in looking back/looking forward to determine vertical alignment and inform collaboration around scaffolding and accommodations with input from Title specialists and special education staff.

Staff members will continue to use a Multi-Tiered System of Support to identify student needs, provide tiered interventions and monitor student progress. In concert with past practice, districts will administer screening and diagnostic assessments as appropriate to better understand each student's current academic level and inform instructional starting points. Benchmark and formative assessments will be utilized to measure student progress and inform instructional next steps. District and school leaders will engage in data analysis around curriculum and instruction to monitor student progress and make instructional adjustments. Special and general education teachers will work collaboratively to meet IEP goals and provide accessibility to any assistive technologies as needed. All staff will work together to provide this support, including teachers, principals, counselors, social workers, etc. by regularly communicating with students and families.

The district will build upon systems to foster equity and access for all students. The district will identify staff responsible for determining levels of interventions for students not participating or responding to instruction. Specific personnel participating in this system may include teachers, administrators, counselors, social workers, etc.

The district will communicate teaching and learning expectations to all stakeholders in various home languages, as feasible and as resources permit. The district will continue to use its English language support system, including the MISD bilingual services, to communicate with non- and limited-English speaking families.

Lake Shore Public Schools is a professional learning community, with established working groups of grade level and content connections, that prioritizes identifying what students need to know (prioritized standards), how those learning standards will be instructed, how learning will be assessed and how students will be supported that demonstrate needs for additional support as well as those meeting and exceeding the standards.

- MTSS processes have been reviewed and are able to be deployed. Support staff has been provided training in learning management systems as well as connecting remotely with students and staff.
- PLCs are scheduled twice monthly, as well as grade level shared preparation times, to allow systematic evaluation of focused standards, achievement and intervention. The committees include building leadership and support staff to ensure appropriate interventions are not only identified but also planned and scheduled. This process remains in place at all phases.
- Partnership with MISD regarding tutoring and support with English Learners will continue.
- Students with 504s and IEPs will continue to receive instruction that is focused on goals and advancing learning. In the event that Phases 1-3 also includes a stay at home order, best effort will be made to provide services such as speech and language, occupational therapy and physical therapy virtually, in collaboration with MISD.

Section 4: Special Education

- (a) When a district provides in-person instruction to its students without disabilities, the district must also provide in-person instruction to its students with disabilities, consistent with their individualized education plans.
- (b) When schools are closed to in-person instruction, districts must strive in good faith and to the extent practicable, based upon available resources, technology, training, and curriculum, as well as the circumstances presented by COVID-19, to provide equal access to any alternative modes of instruction to students with disabilities from birth through age 26. This includes the provision of auxiliary services under section 1296 of the Revised School Code, MCL 380.1296.
- (c) While any state of emergency or disaster related to the COVID-19 pandemic continues, districts shall comply with guidance from the United States Department of Education, including its Office of Civil Rights and Office of Special Education and Rehabilitative Services, and the Michigan Department of Education concerning the delivery of alternative modes of instruction to students with disabilities in light of the impact of COVID-19.
- (d) Districts shall, to the extent practicable and necessary, make individualized determinations whether and to what extent compensatory services may be needed for students in light of the school closures during the 2019–2020 school year.
- (e)The state will not penalize a district or a nonpublic school that has been allocated federal funds for the purpose of providing special education services due to a school's inability to provide those services on account of a school closure prompted by a COVID-19 state of emergency or disaster.

Section 6: Implementation:

- (a) All provisions of Executive Order 2020-65 suspending strict compliance with the School Aid Act or the Revised School Code for the 2019–2020 school year including all provisions in Part I(2) through Part I(13) and all provisions in Parts IV, VII, VIII, and IX—remain in effect through the fiscal year ending September 30, 2020.
- (b) Except as provided for in subsection (a) of this section, Executive Order 2020-65 is rescinded.
- (c) The limitation on the size of indoor social gatherings and events in section 5 of Executive Order 2020-110 or any executive order that may follow from it does not apply to students in a classroom setting.
- (d) All schools, public and private, are subject to the rules governing workplace safeguards established in section 1 of Executive Order 2020-114.
- (e) For purposes of this order, a district that straddles regions will be treated as if it were located solely in the region designated as higher risk.
- (f) All schools, public and private, must cooperate with the local public health department if a confirmed case of COVID-19 is identified, and in particular must collect the contact information for any close contacts of the affected individual from two days before he or she showed symptoms to the time when he or she was last present at the school.
- (g) A district or nonpublic school without an approved Preparedness Plan is not permitted to open or to continue in operation for in-person instruction for the 2020–2021 school year.
- (h) To mitigate the impact of COVID-19 on educational outcomes, a district may adopt year-round school or a year-round program for the 2020–2021 school year or start the 2020–2021 school year before the first Monday in September.
- (i) Any closure of schools relating to COVID-19 shall not affect an employer contribution, employee contribution, or the accrual of service credit under the Public School Employees Retirement Act of 1979, 1980 PA 300, as amended, MCL 38.1301 to 38.1467.
- (j) For a district with a collective bargaining agreement, this order must be implemented by the district in a manner consistent with the collective bargaining agreement.
- (k) When the Michigan Department of Education or the Superintendent issues a waiver or suspends an administrative rule pursuant to this order or Executive Order 2020-65, the Superintendent must provide the governor in writing with a copy of the waiver and information relating to the issuance or suspension. Any waiver issued by the Superintendent under Part VII of Executive Order 2020-65 continues in effect through the end of the fiscal year unless otherwise rescinded by the Superintendent.
